This is supplemented by the operation and marketing of third-party plants, a European energy trading business, and direct energy sales to business customers in Europe.

#### Establishing a Project Portfolio Management system

In order to establish the portfolio management at Alpiq for IT related projects, the first measure was to create an Excel list in which all current projects were listed.

> "We encountered the limitations of the Excel list relatively quickly because we realized that even though we could create some transparency, we were not able to develop ourselves further. Above all, topics such as resource planning, clean budget planning, and project status reporting could not be handled with Excel. Thus, we had to look for a suitable tool."

As a result, an evaluation of various portfolio management tool providers was made. However, since no suitable candidate was found at this time, it was not reasonable for Alpiq to introduce a new tool yet.



A year later, Mr. Petrovic received the recommendation from a colleague in another department to look into Keto Software as a possible solution. Therefore, the previously listed criteria were brought up again and compared with Keto's project portfolio management tool and it turned out to be the right fit for Alpiq's needs.

### More transparency and better data quality

As a next step, the tender document was sent to Keto's experts. After an evaluation and self-assessment against the listed criteria, Keto provided feedback on each of the functionalities required by Alpiq.

> "Keto performed very well, also in comparison to other providers, in terms of our requirements", says Mr. Petrovic who is very satisfied not only with the introduction of Keto's solution but also with the result.

"The implementation process of Keto was very easy and straightforward. Thanks to the tool, we are now able to manage projects and resources in the portfolio and track and measure them transparently and in realtime."

Alpiq introduced the Keto5 platform in 2020 and is therefore still in an early stage. Nevertheless, the impact of Keto Software's platform is already noticeable.

Mr. Petrovic sees advantages that Keto has brought for Alpiq above all in the **data quality** and the **enhanced information content** about the projects. "We have been able to **increase the maturity in project management** by establishing a workflow with various phases that a project must run through, including the appropriate governance bodies that do the project approval."

In addition to features such as **portfolio management, risk management, and status reporting**, Alpiq was recently able to introduce **resource management**, which allows for detailed planning of resources on the projects.

An important measure, since the reason why projects are not completed on time, is usually due to resources, as responsibilities are not planned efficiently.

"With Keto, we have the possibility to assign resources to projects, get those approved by their line managers and if needed to reschedule again.

The different views on resources allow us to elaborate under- and over capacities per employee or project. By optimizing the assignments, **we can increase efficiency**."




As a human-centric platform, Keto enables customization by **adapting to the customers' needs and individual processes**. Mr. Petrovic describes what this means for Alpiq as follows:


